The current version of **Citrix Workspace Environment Management: Profile Cleanser** was tested for conformance with Section 508 of the Rehabilitation Act, specifically the U.S. Access Board's Technical Requirements. This product was tested as of **October 27, 2017**, and is only valid for the version and date it was tested.

Assistive technology products used as part of testing included Freedom Scientific JAWS 18.0, AI Squared ZoomText 11, Inspect, Microsoft Windows accessibility features, and keyboard-only control.
